

## Clarification Request

Hot Chili Limited (ASX: HCH) (TSXV: HCH) (OTCQX: HHLKF) (“Hot Chili” or the “Company”) refers to the Company’s release dated 9 July 2024 titled “*Hot Chili Corporate Presentation Rule Symposium*” (**Presentation**).

The Company wishes to provide further clarification and information in relation to the disclosure of exploration targets in the Presentation in accordance ASX Listing Rule 5.23 and the disclosure of production targets and forecast financial information in the Presentation in accordance ASX Listing Rule 5.19:

### **Polarisation survey at Productora**
